Upon the 2010 Organization Review and the subsequent restructure of the core businesses and governance of the Council, conducted by the Executive Committee (ExCo), a Task Force was appointed by ExCo in March 2012 to study the membership profile and to propose aligning amendments to the HKCSS Constitution. On 14 August, 2012, the Task Force submitted a report proposing the related changes and was endorsed in principle by ExCo. The proposed amendments to the HKCSS Constitution were to reflect the Council's renewed Vision, and to enhance governance and mandate for the operation of the Council.

The ExCo has decided to conduct a consultation session to explain and collect feedback from Agency Members on all those proposed changes, before calling for an Extraordinary General Meeting in November.
