V11. Computer Programming

1. Task Assignment

Develop a system for a university academic administration affairs using Windows application program. The following processing terms must be fulfilled. In addition, contestants should freely develop unspecified parts by showing their creativity.

1) Processing Terms

- a) Users should be able to add, delete, modify and search data.
- b) File structure of database should be designed and developed along with the data.
- c) Table structures should include fields marked as *, and other fields may be added optionally.
- d) The size and type of the file structure may be specified by the contestants, to suit the task.
 - Table structure for student management
 *Student No., *Name, *Year of entrance, *ID, password, *Date of birth,
 e-mail, *Phone No., Address, etc.
 - Table structure for class management
 - *Student No., Year of attending, Semester, Course code, Name of course, Classification (major requirements, electives, etc.), Professor, Meets (date), Class time, Classroom, Credit, etc.
 - Table structure for grade management
 - *Student No., Year of attending, Semester, Course code, Name of course, Classification (major requirements, electives, etc.), *Points, *Grade, *GPA, etc.

3. Requirements

- (a) Contestants will not be producing the same results of the task, and shall be evaluated on their ability to solve problems. They shall establish various functions of work processes and shall develop a user-friendly program.
- (b) Contestants shall install and confirm the materials on the "List of Tools to be Brought" and facilities on the "List of Facilities Installed at Contest site" 30 minutes before the contest.
- (c) If contestants who wish to bring personal software needs more than 30 minutes for installing, they shall receive the judges' approval and install before the contest.
- (d) Use the contestant number to create a folder on the desk top screen, and save the program.
- (e) Contestants are recommended to save their data regularly to prevent any data loss in case of blackouts or system malfunctions.
 - * Contestants are responsible for any disadvantages gained due to their irresponsibility of not saving the program or mistakes in operating the system.

- (f) Contestants who are finished with the task must receive confirmation of the submitted time from judge and run the program themselves.
- (g) Contestants who wish to bring tools other than the ones on the "list of tools to be brought" shall notify the judges for approval in advance. However, the judges may ban the use of any tools that are considered to give the contestant an unfair advantage.
